- Any goods returned for credit outside the period specified in clause 9 of the [Terms & Conditions](#) listed at www.rolltrakspares.com will be charged a restocking fee of 25% of the purchase price for the goods on returning any non-defective goods.
- All products returned for credit must be in original Rolltrak Spares Pty Ltd packaging and be of merchantable quality. These goods must be returned with the original purchase invoice No. (e.g. copy of invoice).
- Accepted goods returned will only be credited against the original purchase invoice number. Transport &/or freight charges will not be credited. Credit notes when issued will appear on monthly account statements.
